- After completion the assets shall be handed over to User grant (Line Deptt/PRI/ULB etc.) the expenditure will be made out of the fund received vide Govt. order no. PD/DCP/32/2015/42 dated 5/10/15 under MLALADS of Tezpur LAC for the year 2015-16.
