In case quotationer are absent at the opening of the tenders, the undersigned will reserve the right to open and finalize the tenders in their absence.

- 1. The offset printing press must be registered by the Printing & Stationery Dept., Govt. of Assam and must have sufficient manpower and machinery to meet emergent need.
- 2. Rates should be inclusive all Taxes but exclusive of GST. The rates of printing should be inclusive of the cost of papers also (i.e. cost of printing with paper).
