Applications are hereby invited in the Standard Form Part IX of Assam Gazette along with other testimonials from the intending candidates for filling up 7 (seven) vacant posts of Peon (Grade-IV) in the office of the undersigned and office of the S.D.J.M.(M),Gohpur under the establishment of the Chief Judicial Magistrate, Sonitpur, Tezpur in the Pay Band and Grade Pay with other allowances as admissible under Rules as shown below.

Terms and Conditions :

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates must have registered their names in the Employment Exchange and the Registration Numbers along with the date must be mentioned in their applications.
3. Candidates already serving in Govt. Department should submit their application through proper channel.
4. Candidates must have passed Class VIII, but Candidates who have passed HSSLC or above shall be ineligible to apply for the aforesaid post.
5. Candidates must not be less than 18 years of age or more than 38 years of age as on 01.01.2020. The upper age is relaxable as per Govt. norms.
6. The application with self attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card, along with 3 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side should reach the office of the undersigned.
7. The applicant should mention their Mobile Numbers in the application without fail.
8. The last date of receipt of application form is 16.06.2020 up to 5 p.m. No application will be accepted after the last date of submission. The undersigned shall not be responsible under any circumstances for any postal delay.

9. Envelope containing application should indicate the name of the post and category to which they applied for on the top in the Block letters as-“ **APPLICATION FOR THE POST OF OFFICE PEON/COURT ATTACHED PEON/ PEON (ATTACHED PEON).** *Women candidates who wish to apply under “Women Reserved Category” against the post mentioned in the Sl. No. 1 & 2 shall indicate their choice in the Standard Application Form as well as in the top of the Envelope. Those who failed to do so, their application shall not be considered under the said category.*

In view of the ongoing Pandemic Covid-19, in order to avoid mass gathering as well as to maintain social distancing and to follow all the guidelines as laid down by the Govt. of India, the Recruitment Committee has decided to hold only Oral Interview for the aforesaid posts. The eligible candidates applying for the post shall be required to appear before the interview board as and when called for. In this context, the candidates are requested to wear face mask, maintain social distancing and follow other rules and regulations laid by the MHA, Govt. of India while attending the interview.

The list of eligible candidates along with specific date of interview shall be uploaded in the official website of Sonitpur District Judiciary (www.sonitpurjudiciary.gov.in) in due course and also be intimated through SMS. **No separate call letters will be issued.** Applicants are advised to go through the official website regularly.
12. The applicants shall submit their application in a drop box made available for the same in front of the office of the Chief Judicial Magistrate, Sonitpur, Tezpur or they may submit through ordinary postal service.
13. Interview centre : **Tezpur** (Date & Venue will be notified in the official website and through SMS).
14. No TA/DA will be admissible to the candidates for appearing in the interview.
15. Application received late or without proper supporting documents or unsigned or without photographs or incomplete Application Form will be summarily rejected.
16. Canvassing directly or indirectly shall disqualify a candidate.


