ORDER
U/S 144 Cr.P.C.

Whereas it appears to me that some persons are possessing, selling and carrying Sharp-edged and deadly weapons, namely Swords (including swordsticks), daggers, bayonets, spears (including lances and javelins), battle-axes, knives (including Kirpans and Khukries) and other such weapons with blades longer than 9" or wider than 2" and machinery for making arms other than those designed for domestic, agricultural, scientific or industrial purposes, steel baton, "Zipo" and other such weapons called 'life preservers',

And whereas, as per Arms Rules, 2016, all above described arms as mentioned in Schedule -I can be possessed only under valid arms licence issued by the District Magistrate in competent cases as described in Schedule-II,

And whereas, I am made to understand that miscreants/ anti-social elements are likely to take advantage of use of such unauthorized weapons and may try to indulge in acts of violence during the upcoming festive seasons like Independence day, Mohharram, Durga Puja, Kalipuja and other religious festivals,

And whereas, users of such weapons have to obtain licence from the concern issuing authority, otherwise will be tantamount to be an offence under Arms Act ,

And, whereas, I am satisfied that emergent steps are required to be taken to prevent sale and possession of such weapon without valid licence that may cause breach of public peace and tranquility in the District


And whereas, in my opinion, there is sufficient grounds for proceeding under Section 144 Cr.P.C. for possessing, selling and carrying of weapon mentioned above.

Now, therefore, in exercise of the power conferred upon me U/S 144 Cr.P.C., I, **Kishan Kumar Sharma, ACS. Addl. District Magistrate, Sonitpur** do hereby order as follows :-

1. No person shall possess, sale or carry any type of sharp weapon with blades longer than 9" or wider than 2" other than those designed for domestic, agricultural, scientific or industrial purposes etc. in the jurisdiction of entire Sonitpur District.
2. Any person desires to possess such weapon must obtain licence from the competent authority as per provisions of Arms Rule, 2016.
Any violation of this order will invite penal action as per Arms Rule, 2016.
3. The Officer-in-Charge of all Police Stations of Sonitpur District shall ensure compliance of this order.

This order shall come into force with effect from 2nd August, 2019 until further order.


Note: - Due to exigencies, this order is given ex-parte, however any aggrieved party/Person may approach the competent authority for modification/waiver of the order.
