

MINUTES OF THE MEETING IN CONNECTION WITH "AXOM ADARXO GRAM YOJANA (AAGY)"
HELD ON 22/10/2021 AT 4:00 PM IN THE NEW CONFERENCE HALL, OFFICE OF THE DEPUTY
COMMISSIONER, SONITPUR, TEZPUR.

Smt Romy Baruah, ACS, Additional Deputy Commissioner (Dev.), Sonitpur, Tezpur presided over the meeting. She welcomed all the members present and requested Sri Biraj Boruah, SDO (Sadar), Tezpur, Sonitpur to brief the guidelines of "**AXOM ADARXO GRAM YOJANA (AAGY)**", 2018-19.

The Sub-Divisional Officer (Sadar), Tezpur, Sonitpur cum Branch Officer, Transformation & Development Branch, DCs Office, Sonitpur then elaborated the Guidelines and informed all concerned Block Development Officers that in total an amount of Rs. 135.00 Lakh (Rupees One Hundred Thirty Five Lakh) has been already transferred to concerned VLCs as 1st installment against the 9 nos. of selected villages under AAGY (@ Rs.15.00 lakh per village) of Sonitpur District for implementation/execution of schemes under AAGY.

Also, it was unanimously decided that in order to achieve uniformity in all 9 nos. of AAGY villages 4 nos. of Model Estimates are prepared namely **(1) Const. of Entry Gate (2) Installation of Solar Street Light (3) Approach Road from the Entry gate and (4) Const. of Community Toilet Block (Ladies & Gents) with Water Supply Facility**. This has the consent of the Deputy Commissioner, Sonitpur.

As per instruction of the Deputy Commissioner, Sonitpur, the Addl. Deputy Commissioner (Dev.), Sonitpur directed all concerned Block Development Officers to utilise the Model Estimates as reference which may later be modified as per requirement.

The Addl. Deputy Commissioner (Dev.), Sonitpur also directed all concerned Block Development Officers to conduct a meeting to form the Construction Committees of all submitted schemes as per AAGY Guideline immediately and submit the Plan & Estimate to the Deputy Commissioner, Sonitpur, Tezpur within 3 (three) days without fail for approval of the DLC.

The meeting ended with vote of thanks from the chair.
